IT IS FURTHER AGREED AND ORDERED that John W. Wachsmith shall cease and desist from offering and selling securities in any manner in violation of RCW 21.20.140, the securities registration section of the Securities Act of Washington.

1 IT IS FURTHER AGREED AND ORDERED that John W. Wachsmith shall cease and desist
2 from offering and/or selling securities in violation of RCW 21.20.040, the securities salesperson
3 registration section of the Securities Act of Washington.

4 IT IS FURTHER AGREED AND ORDERED that John W. Wachsmith shall be subject to a fine
5 in the amount of Five Thousand Dollars (\$5,000), with Four Thousand Five Hundred Dollars (\$4,500) of
6 that amount being suspended based on future compliance with this Consent Order. The remaining Five
7 Hundred Dollars (\$500) of the amount of the fine shall be payable to the Securities Division prior to the
8 entry of this Consent Order. In the event of a violation of this Order, the Division will seek enforcement
9 of the Order pursuant to RCW 21.20.395.

10 IT IS FURTHER AGREED that the Securities Division has jurisdiction to enter this Order.

11 In consideration of the foregoing, Respondent John W. Wachsmith waives his right to a hearing
12 in this matter and to judicial review of this Consent Order pursuant to RCW 21.20.440 and Chapter 34.05
13 RCW, and the Securities Division hereby vacates Summary Order to Cease and Desist SDO-05-02 as to
14 John W. Wachsmith except to the extent that the Tentative Findings of Fact and Conclusions of Law in that
15 order have been incorporated herein.
