**INTRODUCTION**

On April 11, 2011, the Securities Administrator of the State of Washington issued Statement of Charges and Notice of Intent to Enter an Order to Cease and Desist, Deny Future Registrations, Impose Fines, and Recover Costs (“Statement of Charges”), S-10-008-11-SC01, against Respondents Corey V. Darling and Wealth Investment Group, LLC.

The Securities Division and Respondents Corey V. Darling and Wealth Investment Group, LLC do hereby enter into this CONSENT ORDER in settlement of the above captioned matter. Respondents Corey V. Darling and Wealth Investment Group, LLC neither admit nor deny the Tentative Findings of Fact and Conclusions of Law as set forth in the Statement of Charges, which are hereby incorporated by reference into this Consent Order.

**CONSENT ORDER**

Based upon the foregoing and finding it in the public interest:

IT IS AGREED AND ORDERED that Respondents Corey V. Darling and Wealth Investment Group, LLC, their agents and employees, each shall cease and desist from offering or selling securities in violations of RCW 21.20.140, the securities registration section of the Securities Act of Washington.

IT IS FURTHER AGREED AND ORDERED that Respondents Corey V. Darling and Wealth Investment Group, LLC, their agents and employees, each shall cease and desist from violating RCW 21.20.010, the anti-fraud section of the Securities Act of Washington.

1 IT IS FURTHER AGREED AND ORDERED, pursuant to RCW 21.20.110(1), that Respondent  
2 Corey V. Darling shall not make application for nor be granted a broker-dealer, securities salesperson,  
3 investment adviser, and/or investment adviser representative license for six (6) years beginning on the  
4 date of entry of this Consent Order by the Securities Administrator.

5 IT IS FURTHER AGREED that the Securities Division has jurisdiction to enter this Consent  
6 Order.

7 IT IS FURTHER AGREED that Respondents Corey V. Darling and Wealth Investment Group,  
8 LLC enter into this Consent Order freely and voluntarily and with a full understanding of its terms and  
9 significance.

10 IT IS FURTHER AGREED that in consideration of the foregoing, Respondents Corey V. Darling  
11 and Wealth Investment Group, LLC waive their right to a hearing in this matter and judicial review of this  
12 order.

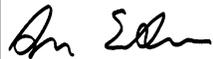
