**INTRODUCTION**

On July 9, 2003, the Securities Administrator of the State of Washington issued a Summary Order Suspending Investment Adviser Registration, S-03-120-03-TO01, against the Respondent, All In One Financial Services, Inc. The Securities Division and the Respondent do hereby agree to this Consent Order in settlement of the above-captioned matter. The Securities Division has, in its Summary Order Suspending Investment Adviser Registration, S-03-120-03-TO01, made certain tentative findings and conclusions, set forth under the headings "Tentative Findings of Fact" and "Conclusions of Law," that are hereby incorporated by reference into this Consent Agreement.

**CONSENT AGREEMENT**

Based upon the foregoing,

IT IS AGREED that All In One Financial Services, Inc. shall file its year-end balance sheet annually with the Washington Securities Division within 90 days after the end of each fiscal year.

IT IS FURTHER AGREED that All In One Financial Services, Inc. shall immediately advise the Washington Securities Division of any change in its business address or business telephone number.

1 IT IS FURTHER AGREED that All In One Financial Services, Inc. shall reimburse the Securities  
2 Division \$500 for costs incurred in its investigation of this matter and that payment shall be made prior to  
3 the entry of this Consent Order.

4 IT IS FURTHER AGREED that the Securities Division has jurisdiction to enter this Consent  
5 Order.

6 In consideration of the foregoing, All In One Financial Services, Inc. waives its right to a hearing  
7 on this matter and the Securities Division hereby vacates Summary Order Suspending Investment Adviser  
8 Registration, S-03-120-03-TO01, except to the extent that the findings and conclusions in that order have  
9 been incorporated herein.

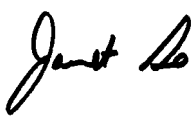
