11 **INTRODUCTION**

12 On December 17, 2010, the Securities Administrator of the State of Washington issued
13 Statement of Charges and Notice of Intent to Issue an Order to Cease and Desist, Impose Fines,
14 and Recover Costs, S-07-294-10-SC01, hereinafter referred to as the "Statement of Charges,"
15 against the Respondents National Strategic Investment Corporation, Real Investor Mortgage,
16 Inc., Starlie, LLC, Charles W. Williams, and Steven M. Hettema. The Securities Division and
17 National Strategic Investment Corporation and Steven M. Hettema do hereby agree to this
18 Consent Order in settlement of the above captioned matter. The Securities Division has, in the
19 Statement of Charges, made certain allegations and conclusions, set forth under the headings
20 "Tentative Findings of Fact" and "Conclusions of Law." National Strategic Investment
21 Corporation and Steven M. Hettema neither admit nor deny the Tentative Findings of Fact and
22 Conclusions of Law, which are hereby incorporated by reference into this Consent Order.

23 **CONSENT ORDER**

24 Based upon the foregoing and finding it in the public interest:

1 IT IS AGREED AND ORDERED that the Respondent Steven M. Hetteema shall cease
2 and desist from violations of RCW 21.20.040, the securities salesperson and broker-dealer
3 registration section of the Securities Act of Washington.

4 IT IS FURTHER AGREED AND ORDERED that the Respondents National Strategic
5 Investment Corporation and Steven M. Hetteema shall cease and desist from violations of
6 RCW 21.20.140, the securities registration section of the Securities Act of Washington.

7 IT IS FURTHER AGREED AND ORDERED that the Respondents National Strategic
8 Investment Corporation and Steven M. Hetteema shall cease and desist from violations of RCW
9 21.20.010, the anti-fraud section of the Securities Act of Washington.

10 IT IS FURTHER AGREED that the Respondents National Strategic Investment
11 Corporation and Steven M. Hetteema enter into this Consent Order freely and voluntarily and
12 with full understanding of its terms and significance.

13 IT IS FURTHER AGREED that the Securities Division has jurisdiction to enter this
14 order.

15 IT IS FURTHER AGREED that in consideration of the foregoing, the Respondents
16 National Strategic Investment Corporation and Steven M. Hetteema waive their right to a hearing
17 in this matter and judicial review of this order.


