INTRODUCTION

On June 24, 2015, the Securities Administrator of the state of Washington issued a Summary Order to Suspend Registration and Notice of Intent to Revoke Registration, Impose a Fine, and Charge Costs order number S-15-1699-15-TO01 ("Summary Order.") The Summary Order together with a Notice of Opportunity to Defend and Opportunity for Hearing and an Application for Adjudicative Hearing was served on Respondents. After the Summary Order was issued Respondent, Higher Order Technologies, LLC, provided the securities division a 2014 fiscal year-end balance sheet and final fund audit. Pursuant to the Securities Act of Washington, Chapter 21.20 RCW, the Securities Administrator and the Respondents; Higher Order Technologies, LLC and Mitchell Eggers; do hereby enter into this CONSENT ORDER in settlement of the matters alleged therein. The Securities Division believes that entry of a Consent Order is in the public interest and is appropriate for the protection of investors. Based on the Findings of Fact and Conclusions of Law set forth in the Summary Order, which are incorporated herein by reference, Respondents and Securities Division agree to the following:

CONSENT ORDER

IT IS AGREED that the Higher Order Technologies, LLC investment adviser registration is withdrawn.

1 IT IS FURTHER AGREED that Respondent Higher Order Technologies, LLC shall pay a fine of
2 \$2,000 and costs of \$200 prior to the entry of this consent order.

3 IT IS FURTHER AGREED that the Securities Division has jurisdiction to enter this Consent Order.

4 IT IS FURTHER AGREED that Respondents enter into this Consent Order freely and voluntarily
5 and with full understanding of its terms and significance.

6 IT IS FURTHER AGREED that in consideration of the foregoing, Respondents waive the right to a
7 hearing and judicial review of this matter pursuant to RCW 21.20.440 and Chapter 34.05 RCW.

8 **AUTHORITY AND PROCEDURE**

9 This Order is entered pursuant to the provisions of chapter 21.20 RCW and is subject to the
10 provisions of RCW 21.20.120 and Chapter 34.05 RCW. Respondents were notified of the right to an
11 administrative hearing and waived it.
