| 17 | taxes owed for the tax period ending December 31, 2002. The Department's investigation also revealed that on or about February 6, 2007, the IRS filed a |
| 19 | second tax lien against the Respondent with the Pierce County Auditor's office for \$118,112.15 in back taxes owed from the tax periods ending December 31, |

The Respondent filed a timely application for an administrative hearing to 1 0 contest the Statement of Charges, which prompted this administrative 2 proceeding before the Office of Administrative Hearings. 3 After an initial prehearing conference, the Department filed a timely Motion for 0 Summary Judgment requesting entry of an order holding the license denial to 4 be proper. The motion was supported by a Memorandum in Support of the Department's Motion for Summary Judgment, the Declaration of Charles E. 5 Woode in Support of the Department's Motion with Exhibits A-C, and Declaration of Service dated April 7, 2008. The Respondent submitted a 6 Response in Opposition to the Department's Motion together with the 7 Declaration of Kirk James Wald and Exhibits 1-8 on May 12, 2008. 8 On May 12, 2008, Administrative Law Judge Mary Ellen Goodwin conducted a 0 telephone hearing on the motion of the Department of Financial Institutions 9 ("Department") for an Order of Summary Judgment in the above-entitled matter, form the Olympia office of the Office of Administrative Hearings. 10 Chad Standifer, Assistant Attorney General, appeared for the Department. John Sterbick, attorney at law, appeared for the Respondent, Kirk James Wald. The summary judgment hearing was tape recorded. 12 On May 12, 2008, Administrative Law Judge Mary Ellen Goodwin issued an 0 Order Denying the Department's Motion for Summary Judgment. 14 On May 21, 2008, at 9:00 a.m. an in person hearing on the merits was held in 0 Tacoma, Washington before Administrative Law Judge Mary Ellen Goodwin. Kirk James Wald suffers from a medical condition diagnosed as "narcolepsy". 0 Mr. Wald's medical condition ... causes frequent periods of inability to focus 0 on his work tasks and financial affairs. By 2000 he was finding it impossible to perform all the duties of his occupation and to manage his financial affairs...he became financially disabled. That condition continues, essentially unchanged to the present. ... STATEMENT OF CHARGES and NOTICE OF INTENTION TO ENTER AN ORDER TO DENY LICENSE APPLICATION

Respondent.

INTRODUCTION

Pursuant to RCW 19.146.220 and RCW 19.146.223, the Director of the Department of Financial Institutions of the State of Washington (Director) is responsible for the administration of chapter 19.146 RCW, the Mortgage Broker Practices Act (Act)¹. After having conducted an investigation pursuant to RCW 19.146.310, and based upon the facts available as of the date of this Statement of Charges, the Director, through his designee, Division of Consumer Services Director Deborah Bortner, institutes this proceeding and finds as follows:

I. FACTUAL ALLEGATIONS

1.1 Respondent Kirk James Wald (Respondent Wald) submitted an application to the Department of Financial Institutions of the State of Washington (Department) for a loan originator license under A+ Mortgage, Inc, a mortgage broker licensed under the Act. The on-line application was received by the Department on or about December 28, 2006.

1.2 Existing Federal Tax Liens. On or about November 7, 2006, and February 6, 2007, the Department of Treasury – Internal Revenue Service, recorded a federal tax lien in Pierce County, Washington (Serial Nos. 200611070517 & 200702060351) for \$166,631.17 in back taxes owed from tax periods ending December 31, 2002 though December 31, 2004.

II. GROUNDS FOR ENTRY OF ORDER

2 2.1 Requirement to Demonstrate Character and General Fitness. Based on the Factual Allegations set
3 forth in Section I above, Respondent Wald fails to meet the requirements of RCW 19.146.310(1)(g) and WAC
4 208-660-350(2)(a) by failing to demonstrate character and general fitness such as to command the confidence of
5 the community and to warrant a belief that the business will be operated honestly and fairly within the purposes
6 of the Act.

III. AUTHORITY TO IMPOSE SANCTIONS

8 3.1 Authority to Deny Application for Loan Originator License. Pursuant to RCW 19.146.220(1), the
9 Director may deny licenses to loan originators. Pursuant to RCW 19.146.310(2) and WAC 208-660-350(7), the
10 Director shall not issue a loan originator license if the conditions of RCW 19.146.310(1) have not been met by
11 the applicant, and shall notify the loan originator applicant and any mortgage brokers listed on the application
12 of the denial.

IV. NOTICE OF INTENTION TO ENTER ORDER

Respondent's violations of the provisions of chapter 19.146 RCW and chapter 208-660 WAC, as set forth in the above Factual Allegations, Grounds for Entry of Order, and Authority to Impose Sanctions, constitute a basis for the entry of an Order under RCW 19.146.220, RCW 19.146.221, RCW 19.146.223 and RCW 19.146.310. Therefore, it is the Director's intention to ORDER that:

4.1 Respondent KIRK JAMES WALD's application for a loan originator license be denied.

V. AUTHORITY AND PROCEDURE

This Statement of Charges and Notice of Intention to Enter an Order to Deny License Application (Statement of Charges) is entered pursuant to the provisions of RCW 19.146.220, RCW 19.146.221, RCW 19.146.223 and RCW 19.146.230, and is subject to the provisions of chapter 34.05 RCW (The Administrative Procedure Act). Respondent may make a written request for a hearing as set forth in the NOTICE OF OPPORTUNITY TO DEFEND AND OPPORTUNITY FOR HEARING accompanying this Statement of Charges.
