CONCLUSION OF LAW 1 Based on the above Findings of Fact, Respondent violated RCW 31.04.025 by engaging in the 2 2.1 business of originating loans subject to the Act in the State of Washington without first obtaining and 3 maintaining a license in accordance with the Act or meeting an exception to the licensing requirement 4 5 under the Act. AGREEMENT AND ORDER 6 The Department and Respondent have agreed upon a basis for resolution of the matters 7 identified in the Findings of Fact and Conclusions of Law sections above. Pursuant to RCW 8 31.04.093(7) and RCW 34.05.060, Respondent hereby agrees to the Department's entry of this 9 Consent Order and further agrees that the issues raised in the above-captioned matter may be 10 economically and efficiently settled by entry of this Consent Order. 11 Based upon the foregoing: 12 A. Jurisdiction. It is AGREED that the Department has jurisdiction over the subject matter 13 of the activities discussed herein. 14 B. Waiver of Hearing. It is AGREED that Respondent has been informed of the right to a 15 hearing before an administrative law judge, and hereby waives its right to a hearing and any and all 16 administrative and judicial review of the issues raised in this matter, or of the resolution reached 17 18 herein. C. License Required. name, address, and telephone number of the individual responsible for maintenance of such records
in compliance with the Act.

F. Authority to Execute Order. It is AGREED that the undersigned has represented and
warranted that she/he has the full power and right to execute this Consent Order on behalf of
Respondent.

G. Non-Compliance with Order. It is AGREED that Respondent understands that failure to
abide by the terms and conditions of this Consent Order may result in further legal action by the
Director. In the event of such legal action, Respondent may be responsible to reimburse the Director
for the cost incurred in pursuing such action, including but not limited to, attorney fees.

H. Voluntarily Entered. It is AGREED that Respondent has voluntarily entered into this
Consent Order, which is effective when signed by the Director's designee.

I. Completely Read, Understood, and Agreed. It is AGREED that Respondent has read
 this Consent Order in its entirety and fully understand and agree to all of the same.
