1 Pursuant to Chapter 4.60 of the Revised Code of Washington, Judgment by Confession,
2 Defendants Alliance Law Center Corp. and Cameron J. Edwards hereby authorize entry of a

4 **Factual Basis for Judgment**

5 The State of Washington, Department of Financial Institutions, and Alliance Law
6 Center Corp. and Cameron J. Edwards have agreed upon a basis for resolution of the matters
7 alleged in Statement of Charges No. C-10-093-10-SC01 (Statement of Charges), entered
8 December 2, 2010. Alliance Law Center Corp. and Cameron J. Edwards have agreed to enter
9 into a Confession of Judgment, pursuant to chapter 4.60 RCW, in the amount of five thousand
10 three hundred thirty-six dollars (\$5,336.00) of which they shall be jointly and severally liable
11 for paying the entire five thousand three hundred thirty-six dollars (\$5,336.00), composed of a
12 fine of five thousand dollars (\$5,000.00) and an investigation fee of three hundred thirty-six
13 dollars (\$336.00), which shall be paid to the State of Washington, Department of Financial
14 Institutions.

15 **Authorization for Entry of Judgment**

16 I, Cameron J. Edwards, being duly sworn upon oath, acknowledge the debt of five
17 thousand three hundred thirty-six dollars (\$5,336.00) to the State of Washington, Department
18 of Financial Institutions, and I authorize entry of judgment against me for the amount set forth
19 in the judgment summary above.

20 As the authorized representative of Alliance Law Center Corp., I also acknowledge this
21 same joint and several debt of five thousand three hundred thirty-six dollars (\$5,336.00) to the
22 State of Washington, Department of Financial Institutions, on behalf of Alliance Law Center
23 Corp., and authorize entry of judgment against Alliance Law Center Corp., for the amount set
24 forth in the judgment summary above.





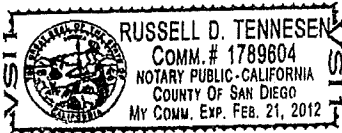
