3 terms:


4 **Factual Basis for Judgment**

11 **Authorization for Entry of Judgment**

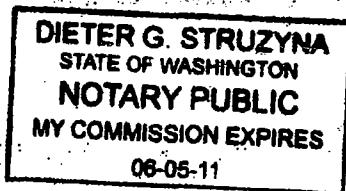
12 I, Cathleen K. Walker, being duly sworn upon oath, acknowledge my debt of \$1,488.00




ORDERED that the Clerk of this Court shall forthwith enter Judgment against Cathleen K. Walker, in accordance with the terms of the Confession of Judgment.
