9 \$1,000.



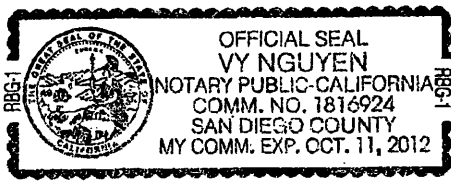
