

Pursuant to Chapter 4.60 of the Revised Code of Washington, Judgment by Confession, Respondents MAAG Inc d/b/a Mill Creek Mortgage and Amy D. Gannon hereby authorize entry of a judgment under the following terms:

#### **Factual Basis for Judgment**

Gannon have agreed upon a basis for resolution of the matters alleged in the Statement of Charges No. C-07-484-09-SC01 (Statement of Charges), entered October 19, 2009. Gannon have agreed to enter into a Confession of Judgment, pursuant to chapter 4.60 RCW, under which the obligations and liabilities of each of them shall be joint and several, in the amount of \$1,872, which will be paid to the State of Washington, Department of Financial Institutions.
