defendant Mark S. Kinder hereby authorize entry of a judgment under the following terms:


Factual Basis for Judgment

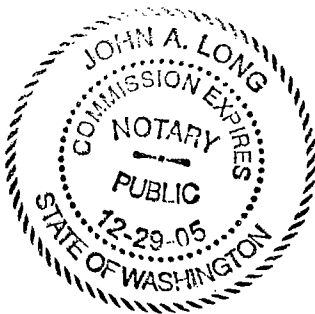




